# Shipping your vehicle from Hawaii State of Hawaii: Removal of Motor Vehicles from the State U.S. Customs and Border Protection: OK to Lade Guidelines

The following is provided by Matson to help its customers shipping vehicles from Hawaii. These guidelines are to assist you but are not legal advice, are not to be acted on as such, and may not be current as laws and regulations are subject to change.

### State of Hawaii: Hawaii Revised Statute 286-57 Unlawful Removal of Motor Vehicles from State

Under Hawaii law, it is unlawful for any person to remove from Hawaii a motor vehicle registered in the State to any other place away from the State, unless the person is the legal owner of the vehicle or has first obtained written authorization from the legal owner of the vehicle.

Every person requesting transportation of their vehicle from Hawaii must provide to Matson:

- (1) a certificate of ownership and a current certificate of registration showing that the person is the legal owner of the vehicle; or
- (2) if the person is not the legal owner of the vehicle, a current certificate of registration showing that the person is the registered owner of the vehicle and, in addition, obtains the written consent of the legal owner of the vehicle to the transportation.

#### U.S. Customs and Border Protection

Pursuant to Title 19 of the Code of Federal Regulations, Section 192.2 (19 CFR 192.2), a person attempting to export (out of the United States and into a foreign country) a used self-propelled vehicle shall present to Customs at the port of exportation, both the vehicle and required documentation describing the vehicle, which includes the Vehicle Identification Number ("VIN") or, if the vehicle does not have a VIN, the product identification number ("PIN"). Exportation of a vehicle will be permitted only upon compliance with these requirements, unless the vehicle was entered into the United States under an in-bond procedure, a carnet, a Temporary Importation Bond, or under a personal exemption for non-residents who entered the vehicle for a 1-year period (19 CFR 148.45).

For shipments of vehicle(s) shipped or transshipped from Honolulu; the customer must do the following:

### The vehicle must be in the Honolulu Matson Port for the OK to Lade process to begin.

- 1. A customer with a U.S.-titled vehicle is required to present the following documents in person or by mail to the U.S. Customs and Border Protection office (see below for address) 72 hours prior to being exported/sailing from Honolulu:
  - a. Booking Confirmation provided by Matson (sent via e-mail after the booking is made)
  - b. Valid ID of owner(s).
    - i. If any of the owners is not present, a notarized letter (from that the owner authorizing the person dropping off to ship) is required.
  - c. Proof of Ownership.
    - i. If the vehicle is owned by the customer/shipper, the original and two complete copies of the Certificate of Title must be presented to the U.S. Customs and Border Protection office in Honolulu.

- ii. If the vehicle has a lien or is financed, a Letter of Authorization allowing the vehicle to be exported from the U.S. will be required. This letter must be from the lien holder, in writing and on their letterhead. The letter must contain a complete description of the vehicle including the VIN, the name of the owner or lienholder of the vehicle, and the telephone numbers at which the owner or lienholder may be contacted. The letter must be notarized and bear an original signature of the third-party. The original signed/notarized letter of authorization must be presented to the U.S. Customs and Border Protection office in Honolulu.
- iii. If the used vehicle is owned by a U.S. government employee and is being exported in conjunction with that employee's reassignment abroad pursuant to official travel orders, then, in lieu of providing a Certificate of Title, the employee may be required to establish that he or she has complied with the sponsoring agency's internal travel department procedures for vehicle export.
- 2. The U.S. Customs and Border Protection office will do an examination of the vehicle while in the Matson Honolulu yard. If all the paperwork is found to be in order, and if the examination of the vehicle is satisfactory, Customs will stamp the booking confirmation with "U.S. Customs and Border Protection Vehicle Export; Permission to Lade"
- **3.** The U.S. Customs and Border Protection office will then notify the Honolulu Matson office of the OK to Lade, so the unit may be shipped.

#### Additional Notes:

Cut off for the Tuesday sailing out of Honolulu is the Wednesday prior, vehicles may in-gate earlier, but if the vehicle in gates after the Wednesday cut off, it will not load until the following week.

If the vehicle is trans-shipping in Honolulu the vehicle must be available for the Customs and Border Protection inspection 72 hours (3 work days) prior to the sailing, if not it will sail the following week.

Note: If mailing documents above to U.S. Customs and Border Protection, please include a self-addressed stamped envelope with the documents, so the original documents may be returned via mail.

## **Important requirement for destinations to:**

With the exception of Guam, Pago Pago, Rota, Saipan and Tinian, all shipments require an Automated Export System ("AES"). U.S. Customs and Border Protection requires mandatory pre-departure, electronic filing of export cargo through the AES.
