- Matson will pass-thru increases in Wharfage Charges assessed by the State of Hawaii. The State of Hawaii intends to increase its wharfage charges in July, 2020.
- Shipments are subject to the State of Hawaii Facilities Security Charge. The current charges are \$20.44 per container to or from the port of Honolulu and \$30.66 per container to or from the ports of Hilo, Kawaihae, Kahului or Nawiliwili. The State of Hawaii intends to adjust this charge in July, 2020.
- Rates are filed in Matson Tariffs 14-F Item 9996-A and 15-F Item 9956-A.
